









European Union Construction Week 2015 in Latvia

In 2012 the Commission issued a Communication on the "Strategy for the Sustainable Competitiveness of the Construction Sector and its Enterprises" for the EU Member States focusing on facilitating sustainable growth and development in the construction industry. This Communication was accompanied by an Action Plan, commonly known as "Construction 2020", which aims to support the construction industry in its adaptation to key upcoming challenges and to promote the sustainable competitiveness of the industry.

The main tasks of the Strategy are to improve competitiveness of companies working in the construction industry, to promote the construction companies raising their qualification, to implement the European challenges in the energy efficiency and sustainability, as well as to modernize the regulation and communication of the construction environment in the EU Member States in the context of internal market.

To implement this Strategy the Construction Week 2015 will be held in Latvia from 2 to 5 June, in the framework of which different activities foreseen for the construction sector will take place.

The Construction Week is organized by the Construction State Control Bureau in cooperation with the Ministry of Economics of the Republic of Latvia, the Latvian National Standardization Body "Latvian Standard", the Latvian Construction Contractors Association and other state institutions and non-governmental organizations related to the construction industry.

Visit for **professionals and scientists** to Polygon of the test buildings of VTPMML (University of Latvia, Faculty of Physics and Mathematics, Laboratory for Mathematical Modelling of Environmental and Technological Processes) at the Botanical Garden of the University of Latvia on 3rd of June, 2015. The professor of the University of Latvia Andris Jakovics has made a tests bench for performance of different tests and the monitoring of energy efficiency (www.eem.lv) since 2011, including those for adoption of the EU Directive 2010/31EU on effective performance of buildings regarding energy efficiency.

The professor Andris Jakovics will present to the guests the methodology of tests done, the thermal comfort and performance measurements used in Latvia, the conclusions made and future perspectives, as well as answers to the question will be given.
